



NITAAC Program Summary

The NITAAC program is part of NIH, designated by the OMB to serve as an Executive Agent for three government-wide acquisition contracts (GWACs) for Information Technology (IT) products, services and solutions.

Can be used by any federal agency for faster, easier procurement:

- No special Delegation of Procurement Authority is needed from NITAAC
- Task orders for services/solutions can be awarded in 30 days or less.
- Delivery orders for products/related services can be awarded in 1-3 days
- Easy to use e-ordering systems
- Competitive, pre-negotiated prices for services/solutions that can't go up, but can be negotiated lower
- Product pricing is lower than open market, less than or equal to GSA

NITAAC provides value added customer support including:

- SOW scope assessments within 24 hours
- Personal support from Contract and IT Specialists from pre-award to closeout
- A Customer Support Center to answer any question within 24 hours
- Free training on the NITAAC program and e-ordering systems

Benefits of FAR 16 include:

- Two levels of contract competition – pre-competed at the Master Contract level and can be further negotiated at the task/delivery order level
- No need to synopsise or post requirements competed through an IDIQ contract according to Far Subpart 16.505(a)(1)
- No protest on orders under \$10 million, except on the grounds that the order increases the scope, period, or maximum value of the contract. Protests of orders in excess of \$10 million may only be filed with the Government Accountability Office, in accordance with the procedures at FAR Subpart 33.104.
